The outcome of a deal can often be determined before a single card is played! The auction presents both challenges and opportunities, and it is not always the partnership with the most combined strength that decides the contract.

Today's players are aggressive during the bidding and this workshop provides tips that will improve your judgment and help you make better choices when you have a borderline decision. It takes a closer look at how the experts handle situations such as:

- Preemptive opening bids in all positions at the table.
- Responding effectively when partner makes a preemptive bid.
- Light opening bids in third and fourth position.
- Lead-directing opening bids!
